REGISTER OF MEMBERS' DISCLOSABLE PECUNIARY INTERESTS

The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

Members are required to register the following disclosable pecuniary interests. Members have a disclosable pecuniary interest if it is of a description specified in No's 1 – 7 below and it is the Member's interest, or it is an interest of the following 'relevant person'—

- (i) The Member's spouse or civil partner,
 - (ii) A person with whom the Member is living as husband and wife, or
 - (iii) A person with whom the Member is living as if they were civil partners,
- and the Member is aware that the other person has the interest.

Members must give a description of the nature of the disclosable pecuniary interest and state whether it is their interest or an interest of a 'relevant person' described above, providing the name of the other person and the nature of their relationship to the Member. Guidance notes are attached to assist Members in completing this form.

<p>3 <u>Contracts</u></p> <p>Any contracts with the WSMMPc including any contracts made between a body in which the Member or a relevant person have a beneficial interest.</p>	
<p>4 <u>Land</u></p> <p>Any beneficial interest in land within the Parish.</p>	<p>2 CHURCH HILL STRETTON ON DOWNSMORE RUGBY CV23 9NA</p>
<p>5 <u>Licences</u></p> <p>Any licence (alone or jointly with others) for a month or longer to occupy land in the Parish.</p>	
<p>6 <u>Corporate tenancies</u></p> <p>Any tenancy where to the Member's knowledge the WSMMPc is the landlord and the tenant is a body in which the Member or a relevant person has a beneficial interest.</p>	
<p>7 <u>Securities</u></p> <p>Any beneficial interest in the securities of a body where that body to the Member's knowledge has a place of business or land in the Parish and either;</p> <p>i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total share capital of that body; or</p> <p>ii) if the share capital of that body is more than one class, the total nominal value of the shares of any one class in which the Member or the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.</p>	

HOSPITALITY

You should declare in the Council's Hospitality Register any gift or hospitality you have received in your role as a Parish Councillor, with an estimated value over £25. This can be notified via email to: strettonondunsmoreclerk@gmail.com or directly to Rugby Borough Council.

Any changes to the information stated above must be notified in writing to the Monitoring Officer within 28 days.
